COD System Maintenance Planned For Sunday, September 14, 2008 (09/10/08)

The COD System will undergo routine maintenance on Sunday, September 14, 2008 from 1:30 A.M. until 11:00 A.M. (ET). In addition, the Student Aid Internet Gateway (SAIG) will be unavailable from 3:00 A.M. until 11:00 A.M. (ET) due to its regular Sunday morning maintenance. This activity will result in outages of certain COD System functionality for a period of time. Federal Student Aid appreciates your patience and understanding as it completes this important activity.

An explanation of how this activity will impact COD System availability and processing follows below. Please review this information to determine if processing at your school will be affected.

COD Web Site and System

End of Federal Fiscal Year 2008 – Impact on Funds Availability (09/04/08)

Tuesday, September 30, 2008 marks the end of the Federal fiscal year for the Department of Education (the Department). Some of the Department's core financial systems, including G5 (formerly GAPS), will be on a modified processing schedule while the Department finalizes its processing and accounting for Fiscal Year 2008. These interruptions will impact how the COD System will process financial data and when schools can obtain funds for the Federal student aid programs as follows:

- ***Monday, September 15, 2008 through Friday, September 26, 2008*** – Financial processing between the COD System and G5 will be reduced to once every evening (instead of the normal twice-a-day, morning/evening processing). As a result, early morning processing will be completed in the evening. Current Funding Level (CFL) changes and funding could be delayed by a day.
- ***Friday, September 26, 2008 through Wednesday, October 1, 2008*** – The COD System will accept Academic Competitiveness Grant (ACG), Federal Pell Grant (Pell Grant), National Science and Mathematics Access to Retain Talent Grant (National SMART Grant), Teacher Education Assistance for College and Higher Education (TEACH) Grant, and William D. Ford Federal Direct Loan (Direct Loan) records. However, after 10:00 A.M. (ET) on Friday, September 26, 2008, CFL changes (as a result of actual disbursements) and funding will not be processed by G5 until Thursday, October 2, 2008.

All actual disbursements with a disbursement date from September 26, 2008 through October 2, 2008 must be received by the COD System ***no later than 10:00 A.M. (ET) on Friday, September 26, 2008***, and subsequently accepted by the COD System, in order for them to be included in the funds available for drawdown prior to the shutdown. Disbursements submitted by the deadline but not subsequently accepted, disbursements



submitted after the deadline, and disbursements with a disbursement date after October 2, 2008 will be funded after G5 re-opens on October 2, 2008.

We appreciate schools' patience during this peak processing period and request that a school wait 24 hours after sending a batch to the COD System before contacting the COD School Relations Center to report a missing acknowledgement/response. If the school does not receive the acknowledgement/response within 24 hours after sending the batch, the COD School Relations Center will research the situation and ensure that the acknowledgement/response is sent to the school's Student Aid Internet Gateway (SAIG) mailbox.

Resolved – Last Processing Day Included As “End Date” In August 2008 Month-End Direct Loan SAS Report (09/11/08)

Earlier this week, Federal Student Aid informed schools that they would notice a difference in the “End Date” included in August 2008 month-end Direct Loan School Account Statement (SAS) Reports sent to schools’ Student Aid Internet Gateway (SAIG) mailboxes on September 7, 2008.

Specifically, the “End Date” included in each school’s August 2008 month-end Direct Loan SAS Report is August 29, 2008—the last processing day for the month. Previously, Federal Student Aid included the last calendar day for the month in the “End Date” field.

Again, from a practical standpoint, there is no impact on the data provided in a school’s August 2008 month-end Direct Loan SAS Report. Each month-end Direct Loan SAS Report includes data processed through the last processing day of the month. However, Federal Student Aid recognized that the change in the report’s “End Date” may cause confusion especially in a month such as August 2008 when the last processing day and the last calendar day are not the same.

Federal Student Aid completed its evaluation of reinstating the previous approach and will be doing so. This means that the “End Date” reflected in each month-end Direct Loan SAS Report from the September 2008 month-end report forward will be the last calendar day for the month.

Second 2007-2008 ACG Deobligation Due To No Corresponding Pell Grant (09/10/08)

On September 9, 2008, Federal Student Aid deobligated 2007-2008 Award Year Academic Competitiveness Grant (ACG) disbursements for students who did not have a 2007-2008 Federal Pell Grant (Pell Grant) actual disbursement recorded in the COD System. As noted in the warning message that Federal Student Aid sent to affected schools on August 26, 2008, these ACG disbursements were considered overawards and reduced to a zero dollar amount (\$0.00), even though the disbursements were previously accepted in the COD System. This deobligation affected ACG disbursements at approximately 100 schools.

A school affected by the deobligation will receive or see the following information:

- Receive an AGTX file (AGTX08OP message class) in the school's Student Aid Internet Gateway (SAIG) mailbox indicating the number of students and total amount of the decrease
- Receive a system-generated negative disbursement file (CRND08OP message class/ND document type) in the school's SAIG mailbox
- Receive a new Electronic Statement of Account (AGAS08OP message class) in the school's SAIG mailbox that reflects the decrease, unless there are other offsetting increase adjustments
- See a change in the school's Current Funding Level (CFL) that reflects the reduced disbursements

Notes:

- If all of the ACG recipients at a school had a corresponding 2007-2008 Pell Grant actual disbursement on September 9, 2008, the school was not affected by the September 9th deobligation process.
- Some ACG recipients do not have a corresponding 2007-2008 Pell Grant actual disbursement due to the documented full repayment of the Pell Grant as a result of a Return of Title IV Funds (R2T4) calculation. If a school informed the COD School Relations Center of the student records to which this exception applies, these student records were excluded from the September 9th deobligation process.

2007-2008 ACG, National SMART Grant, And Pell Grant Processing Deadline (09/04/08)
The deadline for electronically transmitting Academic Competitiveness Grant (ACG), National Science and Mathematics Access to Retain Talent Grant (National SMART Grant), and Federal Pell Grant (Pell Grant) records for the 2007-2008 Award Year to the COD System is ***Tuesday, September 30, 2008.***

In two Electronic Announcements posted on September 3, 2008 (and corresponding “COD Processing Update” items), Federal Student Aid provides comprehensive information related to activities and deadlines that coincide with the September 30, 2008 deadline for 2007-2008 ACG, National SMART Grant, and Pell Grant awards. These announcements are about [the September 25-28, 2008 COD System implementation and reporting hardware upgrade](#) and [the September 30, 2008 end of the Federal fiscal year](#). Schools should refer to both Electronic Announcements to ensure that 1) all necessary reports are obtained and 2) all applicable 2007-2008 ACG, National SMART Grant, and Pell Grant origination, disbursement, and change records are submitted and accepted prior to the outages.

As you will read in the announcements and “COD Processing Update” items referenced above, all actual disbursements with a disbursement date from September 26, 2008 through October 2, 2008 must be received by the COD System ***no later than 10:00 A.M. (ET) on Friday, September 26, 2008,*** and subsequently accepted by the COD System, in order for them to be included in the funds available for drawdown prior to the shutdown. This means that all new 2007-2008 ACG, National SMART Grant, and Pell Grant awards and increases to 2007-2008 ACG, National SMART Grant, and Pell Grant awards must be submitted by the 10:00 A.M. (ET) deadline on Friday, September 26, 2008.

Note: In [the September 3rd Electronic Announcement](#), Federal Student Aid informed schools that it will send 2007-2008 Reconciliation Reports to schools’ Student Aid Internet Gateway (SAIG) mailboxes during the period September 4-5, 2008. Due to the mass generation of these Reconciliation Reports, Federal Student Aid will use a “pseudo” Pell ID in the header and trailer of each file. This “pseudo” Pell ID will not be associated with the school that receives the report.

If a school is unable to download and then view, print, or import a report into a spreadsheet as explained in [the September 3rd Electronic Announcement](#), the school can request the report via the [COD Web site](#) or by submitting the batch data request for the appropriate program/award year message class via the SAIG. For information about how to request these reports, refer to Volume VI, Section 8 of the [2007-2008 COD Technical Reference](#).



Second 2007-2008 National SMART Grant Deobligation Due to No Corresponding Pell Grant Warning Message (09/03/08)

On September 2, 2008, Federal Student Aid began processing a message to schools that have reported 2007-2008 National Science and Mathematics Access to Retain Talent Grant (National SMART Grant) actual disbursements for a student who does not have a 2007-2008 Federal Pell Grant (Pell Grant) actual disbursement recorded in the COD System. The message is a warning that these disbursements will be considered overawards and reduced to a zero dollar amount (\$0.00), even if the disbursements were previously accepted in the COD System. The reduction of the affected disbursements is scheduled to occur on September 16, 2008.

Federal Student Aid sent the September 2, 2008 warning message to schools' Student Aid Internet Gateway (SAIG) mailboxes in the message class SGTX08OP. Additionally, Federal Student Aid sent a file of student records reported to the COD System that do not have a corresponding 2007-2008 Pell Grant actual disbursement in the Reconciliation Report message class SGRC08OP. Schools that receive the warning message should review the accompanying Reconciliation Report and, if applicable, report 2007-2008 Pell Grant disbursements for affected students before September 16, 2008.

Note Regarding Exception Process for No Corresponding 2007-2008 Pell Grant Due to R2T4 Calculation:

Some of the student records included in the Reconciliation Report may be for students who do not have a corresponding Pell Grant for the 2007-2008 Award Year due to the documented full repayment of the Pell Grant as a result of a Return of Title IV Funds (R2T4) calculation. A school can inform Federal Student Aid of the student records to which this exception applies by calling the COD School Relations Center by September 12, 2008. A customer service representative will collect the following information from the school via the phone:

- School's Name
- School's Pell ID and G5 Award Number
- Student's First and Last Names
- Student's Social Security Number (SSN)
- Student's Grade Level
- National SMART Grant Award ID
- National SMART Grant Award Amount
- National SMART Grant Award Year-to-Date Disbursement Amount

Upon notification that an R2T4 exception applies, Federal Student Aid will exclude the applicable student records from the reduction scheduled for September 16, 2008.

Peak Processing Reminder – Schools May Not Receive Acknowledgements/Responses As Quickly As Usual (08/27/08)

As a reminder, the COD System processes a large volume of data during this time of year, and it may take a little longer than usual to complete daily processing.

We appreciate schools' patience during this peak processing period and request that a school wait 24 hours after sending a batch to the COD System before contacting the COD School Relations Center to report a missing acknowledgement/response. If the school does not receive the acknowledgement/response within 24 hours after sending the batch, the COD School Relations Center will research the situation and ensure that the acknowledgement/response is sent to the school's Student Aid Internet Gateway (SAIG) mailbox.

TEACH Grant Operational Implementation Guidance – COD System Implementation and Guidance Summary (07/01/08)

The College Cost Reduction and Access Act (the CCRAA), Pub. L. 110-84, authorized the Teacher Education Assistance for College and Higher Education (TEACH) Grant Program for implementation beginning with the 2008-2009 Award Year. The TEACH Grant Program provides up to \$4,000 a year in grant assistance to a student who agrees to serve for at least four years as a full-time teacher in a high-need field in a public or private elementary or secondary school that serves students from low-income families. A TEACH Grant recipient who does not complete the required teaching within a specified timeframe, or fails to meet certain other requirements of the TEACH Grant Program, will be required to repay the TEACH Grant as a Direct Unsubsidized Loan under the William D. Ford Federal Direct Loan Program. During the period June 27-28, 2008, Federal Student Aid implemented COD System functionality that supports the processing of TEACH Grant awards for the 2008-2009 and subsequent award years. This functionality included implementation of the [TEACH Grant Agreement to Serve \(ATS\) Web site](#).



This section contains important notices regarding reports and/or data requests. While we encourage you to review this section, note that some schools may not be impacted by the information presented below.



Resolved – Schools Cannot Import COD System-Generated 2008-2009 Pell Grant Multiple Reporting Records (09/12/08)

Earlier this week, Federal Student Aid informed schools of an issue with the COD System-generated 2008-2009 Federal Pell Grant (Pell Grant) Multiple Reporting Record (MRR). The COD System automatically generates a Pell Grant MRR when a Potential Overaward Process (POP) or concurrent enrollment situation occurs for one or more students at a school (message class PGMR09OP). A school also may request a Pell Grant MRR via the [COD Web site](#) or batch data request.

The layout of the report that was being system-generated was not consistent with the layout provided in Volume VI, Section 8 of the [2008-2009 COD Technical Reference](#). The record length of any 2008-2009 Pell Grant MRR is 450, and field positions 381-385 and 449-450 should be populated with constant spaces. Instead, with the system-generated 2008-2009 Pell Grant MRR, these field positions were being populated with null values. As a result, report data were being shifted to the left beginning with field position 381. This issue did not impact COD System-generated Pell Grant MRRs for other award years or 2008-2009 Pell Grant MRRs requested via the [COD Web site](#) or batch data request.

On September 9, 2008, Federal Student Aid implemented a code fix that resolved this issue. Subsequently, Federal Student Aid confirmed the successful import of COD System-generated 2008-2009 Pell Grant MRR by schools that received reports generated on September 9, 2008.

Notes:

- 1) During the period March 16, 2008 – September 8, 2008, a school may have received COD System-generated 2008-2009 Pell Grant MRRs that it was unable to import. To identify potential overawards before they occur, Federal Student Aid encourages a school that was unable to import a report during the identified period to request a 2008-2009 Pell Grant MRR via the [COD Web site](#) or batch data request.
- 2) Subsequent to resolving the import-related issue communicated in this item, Federal Student Aid identified another issue that impacts all 2008-2009 MRRs and 2008-2009 Year-to-Date (YTD) Records sent to schools' Student Aid Internet Gateway (SAIG) mailboxes since March 16, 2008. This issue affects the accuracy of data provided in two fields within the reports. Issue Alert – Incorrect Format In Two Fields On 2008-2009 MRRs And YTD Records (09/12/08)

Federal Student Aid has identified a format issue with 2008-2009 Multiple Reporting Records (MRRs) and 2008-2009 Year-to-Date (YTD) Records for the Academic Competitiveness Grant (ACG), Federal Pell Grant (Pell Grant), and National Science and Mathematics Access to Retain Talent Grant (National SMART Grant) programs that have been sent to schools' Student Aid Internet Gateway (SAIG) mailboxes since March 16, 2008. These reports may have been automatically generated by the COD System or requested by a school via the [COD Web site](#) or batch data request.

In short, a school is able to import the affected reports; however, two fields within the reports are not formatted as outlined in Volume VI, Section 8 of the [2008-2009 COD Technical Reference](#). The affected reports and fields are as follows:

The format for all of the affected fields is 0000000. The last four digits should represent less than one percent. Instead, with 2008-2009 MRRs and YTD Records sent to schools' SAIG mailboxes, these field positions are not formatted correctly. As a result, the percentages reflected in the reports are incorrect.

Example

The Percent Eligibility Used by Scheduled Award for a student is 25.02 percent. Currently, this would be reflected in one of the affected reports as 0002502. According to the format explained above and in the [2008-2009 COD Technical Reference](#), this would indicate .2502 percent. In this case, an affected report should reflect 0250200, which indicates 25.02 percent.

Note: All Percent Eligibility Used and Total Percent Eligibility Used calculations stored in the COD System, reflected on the COD and National Student Loan Data System (NSLDS) Web sites, and provided on Institutional Student Information Records (ISIRs) are accurate.

Federal Student Aid is finalizing the implementation of the code fix that will resolve this issue and expects that it will be completed very shortly. After Federal Student Aid has resolved the issue, a school will be able to request corrected reports via the [COD Web site](#) or batch data request. Federal Student Aid will update this communication after the issue has been resolved.
