# *Error Files*


## ■ Transaction Rejects

- Batch Level Rejects (File)
  - These rejects are caused by invalid batch CPS header and trailer information (e.g., duplicate batch id or batch record count)
- Record Level Rejects (Data)
  - These rejects are caused by invalid data field content (e.g., numeric values in alpha fields or data out of specific range)







  - ISIRs with EFC, resolution may be required





# Identifying Problems

- ISIRs with Compute Rejects (No EFC)
  - Verifiable Rejects (Questionable)
    - These rejects are caused by *questionable* data that needs to be verified or corrected (e.g., questionable number of family members)
  - Non-Verifiable Rejects (Incomplete)
    - These rejects are caused by *incomplete* or *inconsistent* data that needs to be added or corrected (e.g., unknown citizenship status)



# *ISIRs with EFC*

- SAR 'C' Comments Flag (C)
  - Denoted by a 'C' to the right of the calculated

Indicates Data Match problem that must be

Alerts attention to SAR/FAA comments



# *ISIRs with EFC*

## ■ Assumptions Flags (\*)

- Denoted by an “\*” to the left of the assumed

Assumptions occur most often when fields are

When a value is assumed, it is used in the calculation of the EFC





# *ISIRs with EFC*

- Verification Flag (\*)
  - Denoted by an “\*” to the right of the calculated
  
  - Indicates transactions selected for verification
  
- Correction Flags (#)
  - Denoted by a “#” to the right of the corrected
  
  - Indicate changes to FAFSA or ISIR data processed by the CPS
  
  - Carried forward on all subsequent transactions



# *Correcting Problems*

## ■ Error Files

### – Batch level

- Review layouts in the EDE Technical Reference, check valid field content  
Send file with corrections

### – Record level

- Same as ISIR field resolution
- Check EDE Technical Reference for valid field



# ***Correcting Problems (cont.)***

## ■ ISIR Files

– Once issues are identified there are three options for resolving errors:

- SAR/ISIR Tab
- Quick Correction
- Verification Worksheet tab

Enter corrections for a large number of students in a minimal amount of time

Clear all corrected fields in case of mistakes

Quick way to add your Federal School Code

# *Assumption Overrides*

- Assumption Override Codes instruct the CPS not to make an assumption
- For 1999-2000 there are 7 Assumption
- Assumption Override Codes can be done for either an initial application or a correction
- Must be set on the FAFSA or SAR/ISIR Tab



# ***Reject Overrides***

- Reject Override Codes instruct the CPS not to reject certain data
- For 1999-2000 there are 3 Reject
- Reject Override Codes can be done for either an initial application or a correction
- Must be set on the FAFSA or SAR/ISIR

# ***FAA EFC Adjustment***

- FAA EFC Adjustment may only be done on transactions with an EFC
- Requires a change to a critical field
- FAA EFC Adjustment and Dependency Override can now be done simultaneously (as long as they are done on a transaction)


