Our federal offices as well as our Title IV processors and contact centers will be closed on Tuesday, July 4, 2017 to observe the Independence Day federal holiday. See below for the various centers' operation status on the holiday.

CPS

The Central Processing System (CPS) will accept data on Tuesday, July 4, 2017 but will not process data or send Institutional Student Information Records (ISIRs) until Wednesday, July 5, 2017.

COD System

The Common Origination and Disbursement (COD) System will accept and process data from schools and send back responses/acknowledgments on Tuesday, July 4, 2017, but schools will not be able to receive any federal funds on that day. Requests for changes in funding levels and for funds will not be processed until Wednesday, July 5, 2017.
