### Cohort Default Rate (CDR) Notification Letter

*This information is intended for the person in your organization who is responsible for working with the National Student Loan Data System (NSLDS®). Please ensure the appropriate person receives this update.*

#### Introduction

The purpose of this Technical Update is to notify Guaranty Agencies (GAs) of the new CDR Notification Letter (DRCNL3) report located on the [NSLDS Professional Access](#) website. As indicated in the Fiscal Year 2015 Official Cohort Default Rate letter, this letter replaces the Official Cohort Default Rate letters previously received via email or the U.S. Postal Service. GAs must now obtain a copy of their CDR Notification Letter via the [NSLDS Professional Access](#) website.


To request the GA CDR Notification Letter on the [NSLDS Professional Access](#) website, select the Web Report List link under the Report tab.
