Our federal offices as well as some of our Title IV processors and contact centers will be closed on Monday, January 20, 2020 to observe the Birthday of Martin Luther King, Jr. federal holiday. See below for the various centers' operation status on the holiday.

CPS

The Central Processing System (CPS) will accept data on Monday, January 20, 2020, but will not process data or send Institutional Student Information Records (ISIRs) until Tuesday, January 21, 2020.

COD System

The Common Origination and Disbursement (COD) System will accept and process data from schools and send back responses/acknowledgments on Monday, January 20, 2020, but schools will not be able to receive any federal funds on that day. Requests for changes in funding levels and for funds will not be processed until Tuesday, January 21, 2020.
