Modifications to the Perkins Data Provider Instructions

This information is intended for the person in your organization who is responsible for working with the National Student Loan Data System (NSLDS®). Please ensure that the appropriate person receives this update.

We are pleased to announce the availability of the <u>updated National Student Loan Data System</u> (NSLDS®) Perkins Data Provider Instructions (DPI), Version 8.2 on the Information for Financial Aid Professionals (IFAP) website. This manual explains Perkins Loan reporting requirements and the processes used to add or update Perkins Loans on NSLDS, including how to use the Perkins DataPrep software. The updated manual, dated October 2020, replaces the June 2018 version.

In the following sections, we describe modifications made to the NSLDS Perkins submittal process that are included in this update to the DPI. We have retired or modified various restrictions which are described in Appendix A (Detail Record Layouts) and Appendix B (Tables B-9 and B-10) of the DPI.

We encourage schools and servicers to review this Technical Update as well as the updated DPI, to ensure all data providers have a complete and accurate knowledge of current reporting processes.

Note: Schools and servicers now access tools previously located on the FSAdownload website, such as the Perkins DataPrep software, on the <u>Software and Other Tools</u> page of the IFAP website (https://ifap.ed.gov/software-and-other-tools).

Retired Edits

The errors, listed in the table below, have been retired and will not be produced when reporting on the Date of First Disbursement, Amount of Loan, Date of Loan Status, Date of Enrollment Status Effective, and Amount of Outstanding Principle Balance. Loan records that would have previously received one of these errors will now successfully load into NSLDS as long as there are no other errors identified.

Modified Edits

I. Student's Academic Level

If a borrower's Perkins Loan has been previously reported and successfully loaded on NSLDS or if subsequently reported on and now the Student's Academic Level is unknown, report the Academic Level as blank, which will bypass Error No. 1437.

II. Date of Student's Birth

Schools will not receive Date of Birth Error Code No. 1103, 1280, 1380, or 1381 when there is a successful match to a student that currently exists in NSLDS.

III. Date Entered Repayment

1. When a school is attempting to report a Date Entered Repayment that is earlier than or equal to the Date of (First) Disbursement and the loan is already on NSLDS, Error 1394 (listed below) will be bypassed. The existing Date Entered Repayment in NSLDS will not be replaced.

For loans which have yet to be successfully reported on NSLDS and the Date Entered Repayment that currently being reported is earlier than the Date of (First) Disbursement, the Date of (First) Disbursement will be used as a substitute for the Date Entered Repayment when both of the following conditions occur:

- a. The Date Entered Repayment is on or after the Date of First Disbursement.
- b. The Date Entered Repayment is more than 10 years in the past.

If the Date Entered Repayment in the submittal file does not meet these conditions, the record will not be loaded and an Error 1394 will be returned to the school.

2. When a school is attempting to report a Date Entered Repayment that is greater than or equal to the Date of (First) Disbursement plus 15 years and the loan is already on NSLDS, Error 1395 (listed below) will no longer be produced. The existing Date Entered Repayment will not be replaced.

For loans which have yet to be successfully reported on NSLDS and the Date Entered Repayment that is greater than the Date of (First) Disbursement plus 15 years, Error 1395 will continue to be returned to the school.

IV. Date of Loan Status

1. When a school is attempting to report a Date of Loan Status that is earlier than or equal to the Date Entered Repayment and the loan is already on NSLDS, Error 1397 (listed below) will be bypassed. The existing Date of Loan Status in NSLDS will not be replaced.

For loans which have yet to be successfully reported on NSLDS and the Date of Loan Status that is earlier than or equal to the Date Entered Repayment, the Date of Loan Status in the submittal file will be accepted when either of the following conditions occur:

- a. The Loan Status is a closed or canceled status.
- b. The Date Entered Repayment is more than 10 years in the past.

If the Date of Loan Status in the submittal file does not meet one of these conditions, the record will not be loaded and an Error 1397 will be returned to the school.

2. When a school is attempting to report a Date of Loan Status that is earlier than the Date of (First) Disbursement and the loan is already on NSLDS, Error 1398 (listed below) will no longer be produced. The existing Date of Loan Status in NSLDS will not be replaced.

For loans which have yet to be successfully reported on NSLDS and the Date of Loan Status that is earlier than the Date of (First) Disbursement, the Date of (First) Disbursement will be used as a substitute for the Date of Loan Status when the following condition occurs:

a. The Date of (First) Disbursement is more than 10 years in the past.

If the Date of Loan Status reported in the submittal file does not meet this condition, the record will not be loaded and an Error 1398 will be returned to the school.

V. Date of Disbursement

The Date of Disbursement being reported by schools must now be earlier or equal to the Date Enrollment Period Ends plus 365 days, an increase from 90 days. If the Date of Disbursement reported does not meet this condition, the record will not be loaded and Error 1402 (listed below) will be returned to the school.

VI. Date Enrollment Period Begins

Error 1392 (listed below), associated with the Date Enrollment Period Begins field, will be bypassed when the Date of First Disbursement in the school's submittal file is more than five years in the past.

VII. Date Enrollment Period Ends

Errors 1106, 1125, 1199, and 1393 (listed below), associated with the Date Enrollment Period Ends field, will be bypassed when the loan record the school is reporting already exists on NSLDS.

VIII. Date Deferment Starts

Error 1239 (listed below), associated with the Date Deferment Starts field, will be bypassed when the Date Entered Repayment in the school's submittal file is more than 10 years in the past. The error will also be bypassed if the Date Entered Repayment is less than 10 years in the past and the loan is being reported with an AE or a closed Loan Status.

IX. Amount Outstanding Principal Balance

When a school is attempting to report zero for the Amount Outstanding Principal Balance and and 'AE' for Loan Status, if the loan already exists on NSLDS, Error 1427 (listed below) will be bypassed. The existing Amount Outstanding Principal Balance in NSLDS will not be replaced.
