

Campus-Based Process Transition Timeline Table December 2017–March 2018 Attachment to December 2017 Electronic Announcement

This table shows the expected transition timeline for the Campus-Based processes that occur early in the calendar year, and provides the deadline date for performing the process in the current eCampus-Based (eCB) System as well as the date schools will begin performing the process in the Common Origination and Disbursement (COD) System. The expected date the eCB System will be closed to schools is *February 6, 2018. Note:* It is critical that schools meet all deadlines to ensure that all data is correctly reflected in the system before it closes in February.
